1	WHEREAS, the Tohono O'odham Nation Division of Senior Services was established for the
2	purpose of providing services for the Elders of the Nation; and
3	WHEREAS, funding for the operation of the Elder Nutrition Program is provided from Title III and
4	Title VI of the Older American's Act; and
5	WHEREAS, the implementation of said services requires safe, reliable transportation; and
6	WHEREAS, Elder Nutrition Program provides the following services nutrition (congregate/home
7	delivered), transportation, socialization/recreation and health promotion to benefit
8	Elders of the Nation, as required from the funding agencies; and
9	WHEREAS, 1999 was the year that vehicles were last replaced for Division of Senior Services to be
10	utilized for transportation of Elders to various nutrition sites on the Nation and other
11	events; and
12	WHEREAS, certain services become endangered by vehicles made unreliable from age and use;
13	and
14	WHEREAS, said vehicles experience failures, disrupting safe and efficient transportation for the
15	Elders of the Nation; and
16	WHEREAS, said vehicles receive automotive maintenance despite age and use; and
17	WHEREAS, current policy does not contain a process for Tribal vehicle replacement.
18	NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
19	approves a one time appropriation of \$395,000.00 for replacement of current vehicles
20	used by the Division of Senior Services which have exceeded one hundred thousand
21	miles (100,000) according to the budget attached; fund source for the vehicle
22	replacement will be from the FY 2007 General Revenue Account of the Nation.
23	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
24	Chairman, Vice-Chairman, and any designated official to expend and administer the
25	budget as attached, provided that any amendments affecting the funds or funding
26	level shall be submitted for further prior approval by the Tohono O'odham Legislative
27	Council.
