

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Modifying Resolution No. 06-212, "Approving FY 2007 Bureau of Indian Affairs Budgets
Under Nation's P.L. 93-638 Master Contract)

RESOLUTION NO. 07-470

1 **WHEREAS, in Resolution No. 06-212, the Tohono O'odham Legislative Council accepted \$16,560.99**
2 **in funding for the continuation of the Solid Waste Regulatory - Underground Storage**
3 **Tank Program; and**

4 **WHEREAS, the Solid Waste Regulatory - Underground Storage Tank Program project period**
5 **extends from October 1, 2006 through September 30, 2007; and**

6 **WHEREAS, the indirect cost changed from 17.98% to 19.35% increasing this line item from**
7 **\$1,046.68 to \$2,685.**

8 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
9 **Resolution No. 06-212 by changing the indirect cost from 17.98% to 19.35% as**
10 **described in the attached budget modification #1.**

11 **BE IT FURTHER RESOLVED that the Solid Waste Regulatory - UST Program is authorized to expend**
12 **the funds in the amount of \$16,560.99 beginning October 1, 2006 through September**
13 **30, 2007.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Official, to wit: the Chairman, Vice-Chairman and any designated official are**
16 **authorized to negotiate and execute the grant, provided however, that any**
17 **amendments affecting the funds or funding levels of the grant shall be submitted for**
18 **further prior approval.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH. Day**
20 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
22 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**




