4	WHEREAS, the Solid Waste Regulatory – Underground Storage Tank Program project period
7	with the solid waste Regulatory - Underground Storage rank Program project period
5	extends from October 1, 2006 through September 30, 2007; and
6	WHEREAS, the indirect cost changed from 17.98% to 19.35% increasing this line item from
7	\$1,046.68 to \$2,685.
8	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends
9	Resolution No. 06-212 by changing the indirect cost from 17.98% to 19.35% as
10	described in the attached budget modification #1.
11	 BEIT FURTHER RESOLVED that the Solid Waste Regulatory – UST Program is authorized to expend
12	the funds in the amount of \$16,560.99 beginning October 1, 2006 through September
13	
13	30, 2007.
14	BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham
15	Nation's Official, to wit: the Chairman, Vice-Chairman and any designated official are
16	authorized to negotiate and execute the grant, provided however, that any
17	amendments affecting the funds or funding levels of the grant shall be submitted for
18	further prior approval.

20	of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-AGAINST;

22	Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
	Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
