

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approval of FY 2008 Department of Health & Human Services - Division of Community Health /Tuberculosis Control Services Program – State Budget, Account 12-1410)**

**RESOLUTION NO. 07-477**

1 **WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control Services Program**  
2 **to help prevent the spread of the disease through community education, prevention,**  
3 **early detection, comprehensive regimens and careful follow up with individuals; and**

4 **WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control Services**  
5 **Program has been provided in part through supplemental funding sources; and**

6 **WHEREAS, the Division of Community Health, Tuberculosis Control Services Program desires to**  
7 **continue the services it provides to TB susceptible patients; and**

8 **WHEREAS, the Tohono O'odham Tuberculosis Control Services Program has received funding**  
9 **from the State of Arizona, Department of Health Services for its program; and**

10 **WHEREAS, the Tohono O'odham Nation, Division of Community Health Services through Grants**  
11 **& Contracts has received notification from the TB Program Manager, Arizona**  
12 **Department of Health Services that additional funding of \$5,000 has been identified**  
13 **for the TB State contract for FY 07-08; and**

14 **WHEREAS, a budget in the amount of \$25,000 is submitted for review and approval by the**  
15 **Department of Health and Human Services, Tohono O'odham Nation Legislative**  
16 **oversight committees, Health & Human Services and the Budget & Finance utilize**  
17 **funds to continue the services it provides.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 19 **1. It hereby approves the funding of the Tohono O'odham Tuberculosis Control**  
20 **Services Program from the State of Arizona Department of Health Services and**  
21 **approves expenditures in accordance with the attached budget in the amount of**  
22 **\$25,000.**
- 23 **2. That the duration of this contract shall be from July 01, 2004 and remain in effect**  
24 **as long as the Arizona Department of Health Services agrees to fund the Tohono**  
25 **O'odham Tuberculosis Control Services Program.**

26 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
27 **Nation's Officials, to wit: The Chairman and Vice Chairman and any designated**  
28 **Officials are authorized to negotiate and execute this contract, provided however, that**  
29 **any amendments affecting the funds or funding levels of the contract shall be**  
30 **submitted for further prior approval by the Tohono O'odham Legislative Council.**




