(Approving Department of Health and Human Services, Division of Family Assistance – FY 08
Low Income Home Energy Assistance Program – Budget and Proposal, Account No. 12-1310)

RESOLUTION NO. 07-478

1 **WHEREAS, the Low income Home Energy Assistance Program (LIHEAP) has been beneficial in**
2 **providing financial assistance to eligible low-income households in meeting utility**
3 **needs, i.e., electricity, propane, water and wood; and continues to meet the**
4 **requirements to operate a Low Income Home Energy Assistance Program; and**

5 **WHEREAS, funds have been made available to the Tohono O'odham Nation for FY2008 through**
6 **the State of Arizona, Department of Economic Security, Office of Community**
7 **Partnerships and Innovative Practices (DES/CPIP), in the amount of \$38,390.00**
8 **through Contract No. E6306018, Amendment No.3, for the period of July 01, 2007**
9 **through June 30, 2008; and**

10 **WHEREAS, the Tohono O'odham Department of Health and Human Services, Family Assistance**
11 **Division, Low Income Home Energy Assistance Program has submitted the FY08 Low**
12 **Income Home Energy Assistance Service Methodology and budget in the amount of**
13 **\$38,390.00 for review and approval.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**
15 **authorizes the expenditure of the FY2008 Low Income Home Energy Assistance**
16 **Program(LIHEAP) budget in the amount of \$38,390.00 in accordance with the attached**
17 **budget.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairman, Vice-Chairman, and any designated official to expend and administer the**
20 **budget as attached, provided that any amendments affecting the funds or funding**
21 **level shall be submitted for further prior approval by the Tohono O'odham Legislative**
22 **Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. Day**
24 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**
26 **(d)(2)&(3)and(f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**




