1 **WHEREAS, Initiative IN-01-97 requires that the Nation provide for the annual administrative cost**
2 **of implementing the provisions of the Initiative; and**

3 **WHEREAS, a reserve was established to fund the necessary administrative requirements for the**
4 **Initiative payroll; and**

5 **WHEREAS, due to excessive use of the Enrollment Program copier over the past ten years, the**
6 **equipment is no longer dependable and requires maintenance and service; and**

7 **WHEREAS, the program is in need of dependable equipment that is used daily in the program**
8 **operations; and**

9 **WHEREAS, the Enrollment Program is requesting to amend the FY 2007 Initiative Administration**
10 **budget to add a new line item 750 Capital Equipment to purchase a new Multi-Task**
11 **Copier for the program in the amount of \$7,951.00.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
13 **approves and authorizes to add new line item 750 Capital Equipment to the FY 2007**
14 **Enrollment Initiative Administration budget Amendment #1 for the purchase of a**
15 **Multi-Task copier in the amount of \$7,951.00.**

17 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**

19 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
