14		$are generally tribal of \it ficials appointed by the tribal governments within each service$
15		area; and
16	WHEREAS,	since 1997 representatives of the Tohono O'odham Nation have served on the TLDC
17		from the Tucson Area; and
18	WHEREAS,	the Legislative Council has historically selected members of the Legislative Health and description de
19		Human Services Committee as the TLDC Area Representative and Alternate; and
20	WHEREAS,	the Health and Human Services Committee has recommended that Representative
21		SandraOrtegabeappointedtoserveastheTLDCTucsonAreaRepresentativeandthat
22		Representative Grace Manuel be appointed to serve as the alternate.
23	NOW, THE	REFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:
