

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Request to Authorize the Tohono O'Odham Election Board to Conduct Election for
Sells District and Approval of Election Budget in the Amount of \$7,295.08)

RESOLUTION NO. 07-482

1 **WHEREAS, the Constitution [Election Ordinance] of the Tohono O'odham Nation vests the Tohono**
2 **O'Odham Legislative Council with the authority to regulate elections for public office**
3 **in accordance with Article X; and**

4 **WHEREAS; during the 2007 General Election the Sells District did not have any candidates for the**
5 **office of District Chairperson and Vice-Chairperson therefore allowing the current**
6 **office holders to continue in office pending a decision form the District Council; and**

7 **WHEREAS, on July 12, 2007 after consulting with all four communities and the Election Board the**
8 **Sells District Council by Resolution #SD-28-07 request the Tohono O'Odham**
9 **Legislative Council to Authorize the Tohono O'Odham Election Board to conduct an**
10 **election for District Chairperson and Vice-Chairperson; and**

11 **WHEREAS, a new budget with justification has been prepared by the Election Board and approved**
12 **by the District Council; and**

13 **WHEREAS, the Sells District Council request for authorization to the Tohono O'Odham Election**
14 **Board to conduct elections for the District Chairperson and Vice-Chairperson; and**

15 **WHEREAS, the Sells District Council has authorized costs will be paid by the District for such**
16 **elections.**

17 **NOW ,THEREFORE ,BE IT RESOLVED that the Tohono O'Odham Legislative Council hereby**
18 **approves and directs:**

- 19 **1. The Tohono O'Odham Nation Election Board to conduct an election for Sells**
20 **District Chairperson and Vice Chairperson using the current Election Ordinance.**
- 21 **2. The Sells District Council will be responsible for the payment of the election and**
22 **are authorized to expend funds according to the attached budget in the amount**
23 **of \$7,295.08.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16TH. Day**
25 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**
27 **(d)(2)&(g) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
