

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY07 U.S. Department of Health and Human Services Title IV-B Budget
Modifications – Account Numbers: 11-1335 and 11-1336)

RESOLUTION NO. 07-487

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **U.S. Department of Health and Human Services; and**

3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**
4 **of Child Welfare Services to intervene against child abuse and neglect and to promote**
5 **safe and stable families; and**

6 **WHEREAS, the Nation was notified of an approved Indirect Cost Rate of 19.35% for this budget;**
7 **and**

8 **WHEREAS, the Department of Health and Human Services has prepared the attached FY07 Child**
9 **Welfare Division budget modifications for Title IV-B, subpart 1 - \$130,319.00; and Title**
10 **IV-B Subpart 2 - \$124,350.00, which incorporates the 19.35% Indirect Cost rate and also**
11 **changes amounts in operations line items; and**

12 **WHEREAS, the Executive Branch developed and obtained committee approval of the budgets**
13 **attached and incorporated by this reference, to be effective October 1, 2006 through**
14 **September 30, 2007.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve and authorize the Executive Branch to expend funds for the budgets attached,**
17 **effective October 1, 2006 through September 30, 2007, which budget modification**
18 **incorporates changes for operations line items and the approved 19.35% Indirect Cost**
19 **Rate during this period.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
21 **Chairman, Vice-Chairman and any designated official authorized to expend and**
22 **administer the attached budget modification as attached, provided that any**
23 **amendments affecting the funds or funding level shall be submitted for further prior**
24 **approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH. Day**
26 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (g) of**
28 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
29 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
30 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
