

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving a Two Month Extension on the FY 2007 Sif-Oidak District Budget and  
Changing the Fiscal Year Budget Cycle to October 1 thru September 30)**

**RESOLUTION NO. 07-490**

1 **WHEREAS, the Sif-Oidak District's Fiscal Year 2007 ends on July 31, 2007; and**  
2 **WHEREAS, the District has a draft budget which is still being reviewed by the Communities; and**  
3 **WHEREAS, the Sif-Oidak District Council has reviewed and approved a two (2) month extension**  
4 **for August and September 2007 in the amount of \$170,593.70, per Resolution No. 07-07-**  
5 **02; and**  
6 **WHEREAS, the Sif-Oidak District has sufficient funds to cover the two (2) month extension; and**  
7 **WHEREAS, the Sif-Oidak District Council approved to change its' fiscal year budget cycle from**  
8 **August 1 - July 31, to October 1 - September 30, for future years.**  
9 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does**  
10 **hereby approve a two (2) month extension for the FY 2007 Sif-Oidak District Budget for**  
11 **August and September 2007 in the amount of \$170,593.70.**  
12 **BE IT FURTHER RESOLVED that the Sif-Oidak District does have sufficient funds to cover the**  
13 **\$170,593.70.**  
14 **BE IT FURTHER RESOLVED that the Tohono O'Odham Legislative Council approves the change in**  
15 **the Fiscal Year Budget Cycle from August 1 - July 31, to October 1 - September 30,**  
16 **effective October 1, 2007 and thereafter.**  
17 **BE IT FINALLY RESOLVED that any amendments affecting the funding or funding levels of the**  
18 **attached budget shall be submitted for further prior approval by the Tohono O'Odham**  
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup>. Day**  
21 **of [JULY, 2007] at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Section 1**  
23 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
