

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Monetary Donations and Approving Amendment #1 to the FY 2007
Sif-Oidak District Youth Budget)**

RESOLUTION NO. 07-491

1 **WHEREAS, the Sif-Oidak District Council, at a special meeting held on July 12, 2007, passed**
2 **Resolution No. 07-07-03, "Accepting Monetary Donations and Approving Amendment**
3 **#1 to the FY 2007 Sif-Oidak District Youth budget; and**

4 **WHEREAS, donations were received from the Desert Diamond Casino (\$2,500), Tohono O'odham**
5 **Legislative branch (\$800), Tohono O'odham Utility Authority (\$500), and Cyprus**
6 **Tohono (\$3,000), for a total amount of \$6,800.00, by the Sif-Oidak District on behalf of**
7 **the Youth Council members to attend the Unity Conference in Oklahoma City,**
8 **Oklahoma; and**

9 **WHEREAS, the Sif-Oidak District Youth Budget Amendment #1 is attached; and**

10 **WHEREAS, the Tohono O'odham Legislative Budget & Finance Committee have reviewed the**
11 **attached amendment and recommends approval.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it does**
13 **hereby approves the monetary donations from the Desert Diamond Casino (\$2,500),**
14 **Tohono O'odham Legislative branch (\$800), Tohono O'odham Utility Authority (\$500),**
15 **and Cyprus Tohono (\$3,000), and approves the Sif-Oidak District Youth Budget**
16 **Amendment #1 in the amount of \$6,800.00**

17 **BE IT FURTHER RESOLVED, that the Youth Budget Amendment #1 will be retro active to July 01,**
18 **2007.**

19 **BE IT FINALLY RESOLVED, that any funds affecting the funding or funding levels shall be reviewed**
20 **and approved by the Tohono O'odham Legislative Council prior to expenditures.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25TH Day**
22 **of JULY, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0- AGAINST;**
23 **-0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by Section 1**
24 **(d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
25 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
26 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
27 **Stat. 984).**




