5	WHEREAS, the Enrollment Ordinance enacted by the Legislative Council provides that the
6	Legislative Council shall determine applicant's eligibility for enrollment or adoption,
7	Article VIII, Section 1; and
8	WHEREAS, on February 6, 2006 the Enrollment Committee presented the application for Martiza
9	I. Morales, 2288-GB-05; and
10	WHEREAS, subsequent to approval it was discovered that due to a typo error the Enrollment
11	Program misspelled the first name of Maritza I. Morales on the listing presented to
12	Council; and
13	WHEREAS, as a result of this error, Resolution No. 06-059 shall be amended to correct the
14	spelling of the name of Maritza I. Morales, Roll No. 2288-GB-05; and
15	WHEREAS, the Enrollment Ordinance provides that the Tohono O'odham Legislative Council
16	shall cause the membership roll to be kept current, Article X, Section 3.
17	NOW, THEREFORE, BE IT RESOLVED THAT:
18	1. The Tohono O'odham Legislative Council approves to amend Resolution No. 06-
19	059 to correct the spelling of name Maritza I. Morales, Roll No. 2288-GB-05.
20	2. The Enrollment Committee shall make the necessary changes in the records of
21	the Enrollment Office to incorporate the stated amendment.
