

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 06-059)

RESOLUTION NO. 07-506

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and ordinances for**
2 **governing the enrollment and adoption of members and the relinquishment and loss**
3 **of membership” (Constitution of the Tohono O’odham Nation, Article VI, Section 1(h));**
4 **and**

5 **WHEREAS, the Enrollment Ordinance enacted by the Legislative Council provides that the**
6 **Legislative Council shall determine applicant’s eligibility for enrollment or adoption,**
7 **Article VIII, Section 1; and**

8 **WHEREAS, on February 6, 2006 the Enrollment Committee presented the application for Martiza**
9 **I. Morales, 2288-GB-05; and**

10 **WHEREAS, subsequent to approval it was discovered that due to a typo error the Enrollment**
11 **Program misspelled the first name of Maritza I. Morales on the listing presented to**
12 **Council; and**

13 **WHEREAS, as a result of this error, Resolution No. 06-059 shall be amended to correct the**
14 **spelling of the name of Maritza I. Morales, Roll No. 2288-GB-05; and**

15 **WHEREAS, the Enrollment Ordinance provides that the Tohono O’odham Legislative Council**
16 **shall cause the membership roll to be kept current, Article X, Section 3.**

17 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 18 **1. The Tohono O’odham Legislative Council approves to amend Resolution No. 06-**
19 **059 to correct the spelling of name Maritza I. Morales, Roll No. 2288-GB-05.**
- 20 **2. The Enrollment Committee shall make the necessary changes in the records of**
21 **the Enrollment Office to incorporate the stated amendment.**

22 **The foregoing Resolution was passed by the Tohono O’Odham Legislative Council on the 06TH Day**
23 **of AUGUST, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
24 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
25 **Section 1(h) of Article VI of the Constitution of the Tohono O’Odham Nation, adopted by the**
26 **Tohono O’Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
27 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
28 **18, 1934 (48 Stat. 984).**
