26	2.	. Authorizes (a) the transfer of the sum of <u>\$58,000.00</u> from the Third Per Capita
27		Money Market Account to the Third Per Capita Checking Account established at
28		Bank of America; and (b) upon the authorized signature of the Nation, issuance of

Designates Sells as the distribution site for the disbursement of the eleventh and subsequent payouts of the third per capita checks to members of the Nation. 8 Q 4.
