1	WHEREAS, by Resolution No. 07-441 the Tohono O'odham Nation approved an attorney contract
2	with the law firm of Drinker Biddle & Reath LLP (the "Law Firm") to provide for
3	representation in Washington, D.C. regarding amendment of the Arizona Water
4	Settlements Act; and
5	WHEREAS, on July 17, 2007 the attorney contract was signed by both parties at a meeting in
6	Washington, D.C.; and
7	WHEREAS, upon further review of the Nation's contract approved by Resolution No. 07-441, the
8	Law Firm requested that the Nation delete section X. of the contract dealing with
9	indemnification of the Nation by the Law Firm; and
10	WHEREAS, after review of the matter by the Water Resources Committee and the Domestic Affairs
11	Committee, the two committees agree to delete the section.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council agrees to amend
13	the contract entered into on July 17, 2007 to delete section X. of the contract dealing
14	with indemnification of the Nation by the Law Firm, and authorizes the Chairperson
15	of the Nation to execute a new attorney contract in the form attached hereto to replace
16	the existing contract, provided that the effective date of the contract shall remain July
17	17, 2007 and all other terms of the contract shall remain the same.
