**RESOLUTION NO. 07-523**

1 **WHEREAS, the Tohono O'odham Council has reviewed the recommendations of the Enrollment**  
2 **Committee in accordance with Section I of Article VIII of the Enrollment Ordinance,**  
3 **Ordinance No. 05-81, and has made a final determination that the application of the**  
4 **following applicant for membership in the Tohono O'odham Nation be approved:**

10 **NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named applicant**  
11 **is eligible for enrollment as a member of the Tohono O'odham Nation under Section**  
12 **1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation, and that**  
13 **their application is approved, as herein above indicated.**

14 **BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono**  
15 **O'odham Nation reduce this final determination in writing regarding each of the**  
16 **foregoing applications for enrollment in accordance with Section 1(a) of Article XIII**  
17 **of the Enrollment Ordinance; give notice of this Council's determination in**  
18 **accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the**  
19 **names of each applicant upon the membership roll of the Tohono O'odham Nation**  
20 **in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.**

21 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 09<sup>TH</sup> Day**  
22 **of AUGUST, 2007 at a meeting at which a quorum was present with a vote of 2,041.8 FOR; -0-**  
23 **AGAINST; -0- NOT VOTING; and 492.7[07] ABSENT, pursuant to the powers vested in the Council**  
24 **by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono O'Odham**  
25 **Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting**  
26 **Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16**  
27 **of the Act of June 18, 1934 (48 Stat. 984).**
