Esai G. 9 10 NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named applicant 11 is eligible for enrollment as a member of the Tohono O'odham Nation under Section 12 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation, and that 13 their application is approved, as herein above indicated. 14 BE IT FURTHER RESOLVED that the Chairman and other appropriate officers of the Tohono 15 O'odham Nation reduce this final determination in writing regarding each of the 16 foregoing applications for enrollment in accordance with Section 1(a) of Article XIII of the Enrollment Ordinance; give notice of this Council's determination in 17 18 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the 19 names of each applicant upon the membership roll of the Tohono O'odham Nation 20 in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance. 21 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 09<sup>TH</sup>.
