11	WHEREAS,	on  June  26, 1997  the  Legislative  Council, pursuant  to  Resolution  No.  96-256, approved

15		and family tree, that Jessica V. Childs listed with Roll No. 1538-GV-92 and Jessica V.

17	WHEREAS,	the  Enrollment  Manual  at  page  5, (Filing of Application)  provides  that  once  a  number
18		has been assigned to an application it shall not be changed; and
19	WHEREAS,	Article~X, Section~3~of~the~Enrollment~Ordinance~provides~that~the~Tohono~O'odham
20		Legislative Council shall cause the membership roll to be kept current.
21	NOW, THE	REFORE, BE IT RESOLVED THAT:
22		1. The Tohono O'odham Legislative Council approves to amend Resolution No. 97-
23		256 as follows:
24		That the name Jessica V. Childs, Roll No. 1542-GB-96 be deleted from Resolution
25		No. 97-256 and that Resolution No. 92-463, Roll No. 1538-GV-92 remains the same
