

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 96-260)

RESOLUTION NO. 07-526

1 **WHEREAS, the Legislative Council is vested with the power to “enact laws and ordinances for**
2 **governing the enrollment and adoption of members and the relinquishment and loss**
3 **of membership” (Constitution of the Tohono O'odham Nation, Article VI, Section 1 (h));**
4 **and**

5 **WHEREAS, Article VIII, Section 1 of the Enrollment Ordinance, Ordinance No. 5-81 (as amended)**
6 **provides that the Legislative Council shall determine applicant's eligibility for**
7 **enrollment or adoption; and**

8 **WHEREAS, on September 19, 1989 the Legislative Council, pursuant to Resolution No. 308-89,**
9 **approved Cody N. Johnson, Roll No. 1479-H-89 for membership in the Tohono**
10 **O'odham Nation; and**

11 **WHEREAS, on July 8, 1996 the Legislative Council, pursuant to Resolution No. 96-260, approved**
12 **Cody N. Johnson, Roll No. 1743-H-96 for membership in the Tohono O'odham Nation;**
13 **and**

14 **WHEREAS, the Enrollment Committee has determined, based on the individual's date of birth**
15 **and family tree, that Cody N. Johnson listed with Roll No. 1479-H-89 and Cody N.**
16 **Johnson listed with Roll No. 1743-H-96 is the same individual; and**

17 **WHEREAS, the Enrollment Manual at page 5, (*Filing of Application*) provides that once a number**
18 **has been assigned to an application it shall not be changed; and**

19 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
20 **Legislative Council shall cause the membership roll to be kept current.**

21 **NOW, THEREFORE, BE IT RESOLVED THAT:**

22 **1. The Tohono O'odham Legislative Council approves to amend Resolution No.**
23 **96-260 as follows:**

24 **That the name Cody N. Johnson, Roll No. 1743-H-96 be deleted from Resolution**
25 **No. 96-260 and that Resolution No. 308-89, Roll No. 1479-H-89 remains the same**
26 **to reflect the original number assigned to his application.**

27 **2. The Enrollment Committee shall make the necessary changes in the records of**
28 **the Enrollment Office to incorporate the stated amendment.**
