9		approved Candace J. Manuel, 1637-H-93 for membership in the Tohono O'odham
10		Nation; and
11	WHEREAS,	on November 6, 1995 the Legislative Council, pursuant to Resolution No. 95-518,
12		approved Candace J. Manuel, 1716-H-95 for membership in the Tohono O'odham
13		Nation; and
14	WHEREAS,	the Enrollment Committee has determined, based on the individual's date of birth
15		and family tree, that Candace J. Manuel listed with Roll No. 1637-H-93 and Candace
16		J. Manuel listed with Roll No. 1716-H-95 is the same individual; and
17	WHEREAS,	the Enrollment Manual at page 5, (Filing of Application) provides that once a number
18		has been assigned to an application it shall not be changed; and
19	WHEREAS,	Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham
20		Legislative Council shall cause the membership roll to be kept current.
