

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Enrollment Resolution No. 05-368)

RESOLUTION NO. 07-529

1 **WHEREAS, the Constitution of the Tohono O'odham Nation vests the Legislative Council with the**
2 **powers to "enact laws and ordinances for governing the enrollment and adoption of**
3 **members and the relinquishment and loss of membership" Article VI, Section 1(h);**
4 **and**

5 **WHEREAS, the Enrollment Ordinance enacted by the Legislative Council provides that the**
6 **Legislative Council shall determine Applicant's eligibility for enrollment or**
7 **adoption, Article VIII, Section 1; and**

8 **WHEREAS, pursuant to Resolution No. 05-368 the Legislative Council approved the Enrollment**
9 **application of Esmeralda M. Ruiz, Roll No. 2084-H-03; and**

10 **WHEREAS, due to typo error the Enrollment Program incorrectly listed the Roll No. of**
11 **Esmeralda M. Ruiz, 2084-H-03 to the list presented to Legislative Council on July 11,**
12 **2005; and**

13 **WHEREAS, the correct number for Esmeralda M. Ruiz is Roll No. 2083-H-03; and**

14 **WHEREAS, the Enrollment Manual at page 5 (*Filing of Application*) provides that once a number**
15 **has been assigned to an application it shall not be changed; and**

16 **WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham**
17 **Legislative Council shall cause the membership roll to be kept current.**

18 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 19 **1. The Legislative Council approves to amend Resolution No. 05-368 by changing**
20 **the enrollment number of Esmeralda M. Ruiz to Roll No. 2083-H-03 to reflect the**
21 **number originally assigned to her application.**
- 22 **2. The Enrollment Committee shall make the necessary changes in the records of**
23 **the Enrollment Office to incorporate the stated amendment.**

25 **The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 09TH Day**
26 **of AUGUST, 2007 at a meeting at which a quorum was present with a vote of 2,269.7 FOR; -0-**
27 **AGAINST; -0- NOT VOTING; and 264.8 [05] ABSENT, pursuant to the powers vested in the Council**
28 **by Section 1(h) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
31 **18, 1934 (48 Stat. 984).**
