1 **WHEREAS, the Chukut Kuk District Council did meet on June 9, 2007 in Vamori at which a quorum**
2 **was present; and**

3 **WHEREAS, FY 2007 Budget Amendment/Modification No. 2 was presented to the Chukut Kuk**
4 **District Budget Committee and the Chukut Kuk District Council; and**

5 **WHEREAS, the Chukut Kuk District Council did approve FY 2007 Budget**
6 **Amendment/Modification No. 2 by district Resolution No. 2007-45; and**

7 **WHEREAS, Chukut Kuk District FY 2007 Budget Amendment/Modification No. 2 was presented to**
8 **the TOLC Budget & Finance committee for review.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
10 **the Chukut Kuk District FY 2007 Budget Amendment/Modification No. 2 with the**
11 **creation of new line item 780, attached hereto and incorporated herein.**

12 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**
13 **District FY 2007 budget shall be submitted to the Tohono O'odham Legislative Council**
14 **for prior approval.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
16 **of AUGUST, 2007 at a meeting at which a quorum was present with a vote of 2,353,4 FOR; -0-**
17 **AGAINST; -0- NOT VOTING; and 181.1[07] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
