1 **WHEREAS, the Chukut Kuk District Council did meet on July 14 2007 in Vamori at which a quorum**
2 **was present; and**
3 **WHEREAS, FY 2007 Budget Amendment/Modification No. 3 was presented to the Chukut Kuk**
4 **District Council; and**
5 **WHEREAS, the Chukut Kuk District Council did approve request by the West Villages**
6 **communities to amend/modify their FY 2007 community budget by district Resolution**
7 **No. 2007-52 attached hereto and incorporated herein by this reference; and**
8 **WHEREAS, Budget Amendment/Modification No. 3 was presented to the TOLC Budget & Finance**
9 **committee for review.**
10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**
11 **Chukut Kuk District FY 2007 Budget Amendment/Modification No. 3 with the creation**
12 **of new category, attached hereto and incorporated herein.**
13 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**
14 **District FY 2007 budget shall be submitted to the Tohono O'odham Legislative Council**
15 **for prior approval.**

16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
17 **of AUGUST, 2007 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**
18 **AGAINST; -0- NOT VOTING; and 181.1[05] ABSENT, pursuant to the powers vested in the Council by**
19 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
20 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
21 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
22 **18, 1934 (48 Stat. 984).**
