

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Chukut Kuk District FY 2008 Budget)**

RESOLUTION NO. 07-536

1 **WHEREAS, the Chukut Kuk District Council did meet on July 16, 2007 in Vamori at which a**  
2 **quorum was present; and**

3 **WHEREAS, the District Council did approve the Chukut Kuk District FY 2008 Budget in the amount**  
4 **of \$1,437,130.79 by district Resolution No. 2007-55 attached hereto and incorporated**  
5 **herein by this reference; and**

6 **WHEREAS, the FY 2008 equal distribution of gaming revenues allocated to Chukut Kuk District**  
7 **in the amount of \$1,192,981.78 does not cover the FY 2008 district budget amount; and**

8 **WHEREAS, Chukut Kuk District does have sufficient funds to cover the difference of \$244,149.01;**  
9 **and**

10 **WHEREAS, the Chukut Kuk District FY 2008 budget has been presented to the Tohono O'odham**  
11 **Legislative Council Budget & Finance committee for review.**


12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
13 **the Chukut Kuk District FY 2008 budget in the amount of \$1,437,130.79 and authorizes**  
14 **expenditure of funds.**

15 **BE IT FURTHER RESOLVED that the difference of \$244,149.01 will be funded from Chukut Kuk**  
16 **District savings.**

17 **BE IT FINALLY RESOLVED that any amendments affecting the funding level of the Chukut Kuk**  
18 **District FY 2008 budget shall be submitted to the Tohono O'odham Legislative Council**  
19 **for prior approval**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup> Day**  
21 **of AUGUST, 2007 at a meeting at which a quorum was present with a vote of 1,555.85 FOR; 158.45**  
22 **AGAINST; 639.1 NOT VOTING; and 181.1[05] ABSENT, pursuant to the powers vested in the Council**  
23 **by Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**  
24 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**
