## RESOLUTION NO. 07-538

1	WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the
2	Bureau of Indian Affairs pursuant to authority conferred to the Nation by the Indian
3	Self-Determination Act, Public Law 93-638, as amended; and
4	WHEREAS, the Tohono O'odham Nation desires to continue operation of such functions; and
5	WHEREAS, the Tohono O'odham Nation is not adding any new programs this year; and
6	WHEREAS, the Budget and Finance and the Domestic Affairs Committees have reviewed the
7	Annual Funding Agreement proposal for FY 2008 attached hereto, and recommend
8	approval by the Legislative Council.
9	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council
10	approves the attached Bureau of Indian Affairs Annual Funding Agreement proposal
11	for FY 2008, and authorizes the Chairperson of the Nation to submit the Annual
12	Funding Agreement to the Bureau of Indian Affairs, to negotiate maximum funding
13	and acceptance by the Bureau of Indian Affairs of the terms and conditions contained
14	therein, and to execute the Annual Funding Agreement upon completion of the
15	negotiations.
16 17	The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>13<sup>TH</sup>.</u> Day of AUGUST, 2007 at a meeting at which a quorum was present with a vote of <u>2,353.4</u> FOR; <u>-0-</u>
18	AGAINST;-0- NOT VOTING; and 181.1[05] ABSENT, pursuant to the powers vested in the Council by
19	Section 1 (f) of Article VI of the Constitution of the Tohono O'Od ham Nation, adopted by the Tohono
20	O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
21	Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
22	Stat. 984).
