

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Budget Modification # 2/Amendment #2 to the Advocate Program**  
**FY 2007 Budget)**

**RESOLUTION NO. 07-540**

1 **WHEREAS, the Tohono O'odham Legislative Council ("Council") is vested with the authority " to**  
2 **manage any funds within the exclusive control of the Tohono O'odham Nation,**  
3 **including proceeds derived from lands and resources of the Tohono O'odham Nation,**  
4 **and to appropriate these funds for the benefit of the nation and its members. All**  
5 **expenditures of these funds shall be pursuant to appropriations or budgets**  
6 **authorized under resolutions or in accordance with ordinance of the Tohono**  
7 **O'odham Council"; and**

8 **WHEREAS, the Tohono O'odham Advocate Program ("Program") has presented a Budget**  
9 **Modification detailing the need to create a Major Capital Equipment line item and use**  
10 **insurance settlement amount of \$15,870.00 for the purchase of a replacement vehicle;**  
11 **and**

12 **WHEREAS, the Program has presented the proposed Budget Modification #2/ Budget Amendment**  
13 **#2 to both the Domestic Affairs and Budget and Finance Committees' for approval on**  
14 **August 8, 2007; and**

15 **WHEREAS, the Budget Modification is crucial in order for the Program to effectively meet the**  
16 **needs of its current clients and to adequately meet the needs of its office.**

17 **NOW, THEREFORE, BE IT RESOLVED:**

18 **That the Tohono O'odham Legislative Council approves and authorizes the Budget**  
19 **Modification #2/Amendment #2 to the Advocate Program FY2007 Budget to create a**  
20 **Major Capitol Equipment Line-Item and use the insurance settlement in the amount**  
21 **of \$15,870.00 and salary saving for the purchase of a replacement vehicle for the**  
22 **Advocate Program as attached hereto.**

23 **BE IT FINALLY RESOLVED THAT the Tohono O'odham Legislative Council hereby authorized the**  
24 **Chairman and any designated official to expend and administer the budget as**  
25 **attached, provided that any amendments affecting the funds or funding level shall be**  
26 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day**  
28 **of AUGUST, 2007 at a meeting at which a quorum was present with a vote of 2,353.4 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and 181.1[05] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (d)(2)&(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
