3	members and relinquishment and loss of membership" (Constitution of the Tohono
4	O'odham Nation, Article VI, Section 1 (h); and
5	WHEREAS; Article VIII, Section 1 of the Enrollment Ordinance, Ordinance No. 05-81 as amended)
6	provides that the Legislative Council shall determine applicant's eligibility for
7	enrollment or adoption; and
8	WHEREAS, on July 7, 2003 the Legislative Council by Resolution No. 03-301 approved Vanessa R.
9	Ramirez, Roll No. 2097-H-03 for membership in the Tohono O'odham Nation; and
10	WHEREAS, the Enrollment Committee discovered that Vanessa R. Ramirez was given the same
11	roll number assigned to another member; and
12	WHEREAS, the Enrollment Committee is deleting the roll No. 2097-H-03 of Vanessa R. Ramirez
13	and has assigned new Roll No. 2111-H-03; and
14	WHEREAS, Article X, Section 3 of the Enrollment Ordinance provides that the Tohono O'odham
15	Legislative Council shall cause the membership roll to be kept current.
16	NOW THEREFORE, BE IT RESOLVED THAT:
17	1. The Tohono O'odham Legislative Council approves to amend Resolution No. 03-301
18	as follows:
19	The Roll No. 2097-H-03 for Vanessa R. Ramirez is deleted and changed to the new
20	Roll No. 2111-H-03.
21	2. The Enrollment Committee shall make the necessary changes in the records of the
22	Enrollment Office to incorporate the stated amendment.
