NOW, THEREFORE, BE IT RESOLVED that it is hereby determined that the above named applicant
is eligible for enrollment as a member of the Tohono O'odham Nation under Section

1 1(a) or (b) of Article II of the Constitution of the Tohono O'odham Nation, and that
2 their application is approved, as herein above indicated.

3 **BE IT FURTHER RESOLVED** that the Chairman and other appropriate officers of the Tohono
4 O'odham Nation reduce this final determination in writing regarding each of the
5 foregoing applications for enrollment in accordance with Section 1(a) of Article XIII
6 of the Enrollment Ordinance; give notice of this Council's determination in
7 accordance with Section 2 of Article XIII of the Enrollment Ordinance; and place the
8 names of each applicant upon the membership roll of the Tohono O'odham Nation
9 in accordance with Sections 2 and 3 of Article X of the Enrollment Ordinance.

10 The foregoing Resolution was passed by the Tohono O'Odham Legislative Council on the 10TH. Day
11 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 1,865.85 FOR; -0-
12 AGAINST; 469.45 NOT VOTING; and 199.2 [06] ABSENT, pursuant to the powers vested in the
13 Council by Section 1 of Article II and Section 1(h) of Article VI of the Constitution of the Tohono
14 O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by
15 the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to
16 Section 16 of the Act of June 18, 1934 (48 Stat. 984).




