RESOLUTION NO. 07-551

1	WHEREAS, on June 28, 1997 the Nation's voters approved Initiative No. IN-01-97, the "Tohono
2	O'odham Voice in the Use of Gaming Revenues" ("Initiative"), which authorizes per
3	capita payments to the Nation's members provided that sufficient gaming revenues
4	are available; and
5	WHEREAS, the Legislative Council did adopt the Third Per Capita Revenue Allocation Plan per
6	Legislative Council Resolution No. 06-307; and
7	WHEREAS, the Enrollment Program discovered due to human error one name was duplicated on
8	the third per capita eleventh payout distribution list; and
9	WHEREAS, the Enrollment Program requests to amend Resolution No. 07-510 to delete the
10	duplicated entry of one name: Zenaida Howard and to change the listing count from
11	29 to <u>28</u> for the third per capita eleventh payout distribution list; and
12	WHEREAS, the disbursement of funds to each eligible adult member is contingent upon
13	verification of a member's eligibility and further certification by the Tohono O'odham
14	Legislative Council; and
15	WHEREAS, the dollar amount will change to $\$56,000.00$ to reflect the 28 adult members eligible
16	for the Third Per Capita eleventh payout distribution.
17	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby:
18	1. Approves and authorizes to amend Resolution No. 07-510 to delete the duplication
19	of one name: Zenaida Howard and to change the Certification Listing count from
20	29 to <u>28</u> eligible adult members for the Third Per Capita Eleventh payout
21	distribution.
22	2. That the transfer of funds in the sum of $\$56,000.00$ will reflect the 28 eligible adult
23	members certified by the Tohono O'odham Legislative Council.
