

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Authorization to Continue San Xavier District Government Operations Pending  
Approval of its FY 2008 Budget)**

RESOLUTION NO. 07-555

1 WHEREAS, the San Xavier District is unable to forward its FY 2008 approved budget to the  
2 Tohono O'odham Legislative Council (TOLC) before the end of the fiscal year; and


3 WHEREAS, it is in the best interest of the San Xavier District (District) to continue its fiscal year  
4 operation pending the review and approval of its FY 2008 budget by the District and  
5 TOLC; and

6 WHEREAS, the District has sufficient funds in its treasury to cover all expenditures during this  
7 interim period from October 1 thru November 30, 2007.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves  
9 the San Xavier District to continue to expend funds for its regular operation at the FY  
10 2007 level until its 2008 budget has been reviewed and sanctioned by the Tohono  
11 O'odham Council by November 30, 2007.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11<sup>TH</sup>. Day  
13 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
14 AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section  
15 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
16 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).
