

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving & Supporting the Boys & Girls Club of the Tohono O'odham Nation  
allocation of Surplus Funds of \$200,000.00 for Fiscal Year 2008)**

**RESOLUTION NO. 07-559**

1 **WHEREAS, by Resolution No. 06-541 stating the Tohono O'odham Legislative Council “*commits***  
2 ***to financially assist for fiscal years 2008 & 2009 to promote and enhance the growth***  
3 ***of the O'odham Youth by providing a safe, positive, and enriching program for all of***  
4 ***the Tohono O'odham Nations youth”;* and**

5 **WHEREAS, by Resolution No. 06-541 stating “*the Tohono O'odham Legislative Council hereby***  
6 ***supports the Future Boys & Girls Club of the Tohono O'odham Nation to become a***  
7 ***chartered club of the Boys & Girls Club of America in Indian Country”;* and**

8 **WHEREAS, within the past year the Future Boys & Girls Club of the Tohono O'odham Nation**  
9 **(BGCTON) has signed up over 250 members throughout the Tohono O'odham Nation,**  
10 **after-school program and Summer Services “*providing a safe, positive, and enriching***  
11 ***program for all of the Tohono O'odham Nations youth.*” As well as hundreds of youth**  
12 **who participated in BGCTON events such as; HorseCamps, 2006 Rodeo Series, Young**  
13 **Women are Sacred workshops, Boys Night Out, Girls Night Out, Kentucky Camp, T.O.**  
14 **Youth League (baseball), Six Flags “Red-Eye” summer vacation, and numerous field**  
15 **days to various Tohono O'odham Nation communities; and**

16 **WHEREAS, the BGCTON continues working to become a chartered club of the Boys & Girls Club**  
17 **of America (BGCA) in Indian Country, and with the understanding that this**  
18 **continuation of funding supported by the Tohono O'odham Nation Executive Office**  
19 **and Tohono O'odham Legislative Council is a requirement from the Boys & Girls Club**  
20 **of America (BGCA); and**

21 **WHEREAS, the BGCTON has also applied for other “*grant opportunities specific for Boys & Girls***  
22 ***Clubs in Indian Country on behalf of the Boys & Girls Club of the Tohono O'odham***  
23 ***Nation, as an entity of the Tohono O'odham Nation” by Resolution No. 06-541.***

24 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council hereby**  
25 **authorizes and appropriates from the Surplus Fund, \$200,000.00 to the Boys & Girls**  
26 **Club of the Tohono O'odham Nation for Fiscal Year 2008.**
