

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Sells District FY 2008 Budget in the amount of \$1,192, 981.78)

RESOLUTION NO. 07-560

1 **WHEREAS, the Sells District Chairperson/Treasurer, and the four Sells District Representatives,**
2 **presented the Sells District FY - 2008 Budget to the Tohono O'odham Legislative**
3 **Council for review and approval; and**

4 **WHEREAS, the FY - 2008 Budget in the amount of One Million, One Hundred Ninety Two**
5 **Thousand, Nine Hundred Eighty One Dollars and Seventy Eight Cents (\$1,192,981.78).**
6 **The Budget cost for the Sells District Administration and the four communities of; Ge**
7 **Oidag, Cowlic, North Communities and Sells in the amount of Thirty Thousand**
8 **Dollars \$30,000.00 per community at which the grand total is One Million, One**
9 **Hundred Ninety Two Thousand, Nine Hundred Eighty One Dollars and Seventy Eight**
10 **Cents (\$1,192,981.78); and**

11 **WHEREAS, the Tohono O'Odham Legislative Budget & Finance and the Tohono O'Odham**
12 **Legislative Council did review and approve the Sells District Administrative Budget**
13 **which includes the four communities of Ge Oidag, Cowlic, North Communities and**
14 **Sells.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
16 **Sells District FY - 08 Budget of Administration and Four Communities, totaling**
17 **\$1,192,981.78 according to the budgets attachments hereto.**

18 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
19 **Chairperson and any designated official to expend and administer the budget, as**
20 **attached, provided that any modifications/amendments affecting the funds or**
21 **funding levels of the budget shall be submitted for further prior approval by the**
22 **Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH. Day**
24 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,036.5 FOR; 498.0**
25 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
27 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
