

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Supporting San Lucy District Council's Request to Continue Operations Pending**  
**Approval of the FY 2008 Budget)**

RESOLUTION NO. 07-565

1 WHEREAS, the San Lucy District Council passed Resolution No. SL 09-128-07 requesting approval  
2 from the Tohono O'odham Legislative Council to continue district operations pending  
3 approval of the FY 2008 Budget; and

4 WHEREAS, the district's finance manager has identified that sufficient funds are available to  
5 continue the district's operations; and

6 WHEREAS, it would be in the best interest of the Nation and San Lucy District to continue  
7 governmental functions pending finalization of the district's FY 2008 Budget.

8 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby supports  
9 the San Lucy District Council's request to continue district functions pursuant to  
10 terms and condition of the District's FY 2007 Budget pending approval of the FY 2008  
11 budget.

12 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13<sup>TH</sup>. Day  
13 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,089.8 FOR; -0-  
14 AGAINST; 444.7 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by  
15 Section 1 (d)(2) and (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by  
16 the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
17 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
18 18, 1934 (48 Stat. 984).
