

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Tohono O'odham Nation Fire Department FY 2007 Budget Amendment**  
**No. 2 to use savings from line item 620 Fringe Benefits to pay the Public Safety Personnel**  
**Retirement System Cancer Insurance in the total amount of \$2,990.00 to be taken**  
**from savings in Fringe Benefits)**

RESOLUTION NO. 07-576

1 WHEREAS, the Tohono O'odham Nation Fire Department (TONFD) has received from the Public  
2 Safety Personnel Retirement System (PSPRS) a new insurance cost for cancer  
3 coverage; and

4 WHEREAS, the TONFD is requesting to use savings from line item 620 Fringe Benefits to pay the  
5 amount of \$2,600.00 at a cost of \$100.00 per eligible Firefighter and an additional 15%  
6 late fee of \$390.00 for a total of \$2,990.00; and

7 WHEREAS, the funding to pay this amount will come from a vacant position savings in fringe  
8 benefits.

9 NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby  
10 accepts, approves, and authorizes the Tohono O'odham Nation Fire Department  
11 budget amendment no. 2 to use funding from vacant position savings in line item 620  
12 Fringe Benefits to pay the amount of \$2,600.00 for the PSPRS Cancer Insurance at a  
13 cost of \$100.00 per eligible firefighter and an additional late fee of 15% at a cost of  
14 \$390.00 for a total of \$2,990.00.

15 BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes  
16 the Chairperson and any designated official to expend and administer the budget as  
17 attached, provided that any amendments affecting the funds or funding level shall  
18 be submitted for further prior approval by the Tohono O'odham Legislative Council.

19 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup>. Day  
20 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-  
21 AGAINST; -0- NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by  
22 Section 1(d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the  
23 Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant  
24 Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June  
25 18, 1934 (48 Stat. 984).
