

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2007 TOPD Budget modification No. 4 to use savings from line item 620
Fringe Benefits to pay the Public Safety Personnel Retirement System Cancer Insurance
in the total amount of \$5,260.00 to be taken from savings in Fringe Benefits)

RESOLUTION NO. 07-578

1 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has received from the**
2 **Public Safety Personnel Retirement System (PSPRS) a new insurance cost for cancer;**
3 **and**

4 **WHEREAS, the TONPD is requesting to use savings from line item 620 Fringe Benefits to pay the**
5 **amount of \$4,300.00 at a cost of \$100.00 per Peace Officer; and**

6 **WHEREAS, this also includes a 15% increase for late payment after August 31, 2007 which is an**
7 **additional amount of \$645.00; and**

8 **WHEREAS, the 15% increase for late payment for personnel on the Law Enforcement 638 budget**
9 **will be covered under the tribal budget in the amount of \$315.00 for a grand total of**
10 **\$5,260.00; and**

11 **WHEREAS, the funding to pay this amount will come from a vacant position savings in fringe**
12 **benefits.**

13 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
14 **accepts, approves, and authorizes TOPD budget modification no. 4 to use funding**
15 **from vacant position savings in line item 620 Fringe Benefits to pay the amount of**
16 **\$4,300.00, plus the 15% late fee of \$645.00 for the PSPRS Cancer Insurance and to**
17 **cover the 15% increase for personnel under the Law Enforcement 638 budget in the**
18 **amount of \$315.00 for a total cost of \$5,260.00.**

19 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that it hereby authorizes**
20 **the Chairperson and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level shall**
22 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17th Day**
24 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1(d)(2) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
