

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Appointing Noreen Ignacio-Pablo to the Tohono O'odham Ki:Ki Association Board  
of Directors and Declaring Interim Directors' Terms Expired)**

**RESOLUTION NO. 07-580**

1 **WHEREAS, Ordinance No. 98-03, "Establishment of Tohono O'odham Ki:ki Association" ("Ki:ki**  
2 **Association Ordinance") established the Ki:ki Association and its five-member Board**  
3 **of Directors; and**

4 **WHEREAS, Article V, Section 1(a) of the Ki:ki Association Ordinance, as amended, provides that**

5 **The Board shall consist of five (5) voting members appointed by the**  
6 **Tohono O'odham Legislative Council . . . The Board members shall serve**  
7 **for a period of four (4) years or until their successors are appointed;**  
8 **provided, however, that appointments to the Board shall be staggered in**  
9 **such a way that the terms of office of no more than two members end in a**  
10 **single year. The Legislative Council may appoint no more than five (5)**  
11 **Board members to a single term of more or less than four (4) years for the**  
12 **limited purpose of implementing the staggered term system. Thereafter,**  
13 **all Board members' terms shall commence on March 1 and end on the last**  
14 **day of February.**

16 **WHEREAS, the Legislative Council has temporarily appointed three members of the Legislative**  
17 **Housing Committee as Interim Directors to the TOKA Board in order to allow the**  
18 **Board to achieve quorums to conduct business (Resolution No. 07-435); and**

19 **WHEREAS, pursuant to the terms of Resolution No. 07-435, the appointments of the Interim**  
20 **Directors expire on "the date a total of three or more TOKA Directors of the Board**  
21 **who are not Interim Directors have been appointed"; and**

22 **WHEREAS, the Legislative Housing Committee has interviewed TOKA Board candidate Noreen**  
23 **Ignacio-Pablo and recommends that she be appointed to the Board of Directors**  
24 **effective immediately for a term ending the last day of February 2012 or until her**  
25 **successor is appointed; and**

26 **WHEREAS, Noreen Ignacio-Pablo's appointment will result in the automatic expiration of the**  
27 **Interim Directors' terms.**

28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**

BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that, on the effective date of this Resolution, the terms of Interim Directors Chester Antone, Gerald Fayuant, and Kimberly Listo shall be deemed expired and they shall no longer serve on the TOKA Board of Directors.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 17<sup>TH</sup> Day of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 1,936.9 FOR; 416.5 AGAINST; 181.1 NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 1(b) and 1(c)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




