4		Legislative Council that reflects the needs of the Branch, a copy of the proposed said
5		budget is attached hereto and incorporated herein by reference; and
6	WHEREAS,	the proposed FY 2008 Judiciary Budget includes employees salary in the amount of
7		\$3,559,913.99, other compensation at \$144,039.50, fringe benefits at 31% in the
8		amount of \$1,148,225.58, and operational cost in the amount of \$491,837.13, totaling
9		\$5,344,016.20 for FY 2008; and
10	WHEREAS,	the Judiciary Committee and the Budget and Finance Committee of the Legislative
11		Council of the Tohono O'odham Nation have reviewed this budget and recommends
12		its approval and adoption.
13	NOW, THER	EFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation
14		has reviewed and approved the Fiscal Year 2008 budget submitted by the Judicial
15		Branch.
16	BE IT FURT	THER RESOLVED that funds in the amount of \$5,344,016.20 is appropriated and
17		authorized to be expended from the general fund approved by this Council for
18		support of the Fiscal Year 2008 budget of the Tohono O'odham Judicial Branch.
19	BE IT FINAI	LLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
20		Chief Judge and any designated official to expend and administer the budget as
21		attached, provided that any amendments affecting the funds or funding level shall
22		$be submitted for further prior approval \ by the \ Tohono\ O'odham\ Legislative\ Council.$
