

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the Fiscal Year 2008 Budget for the Tohono O'odham Nation Justice Center
and Appropriating Funds in the Amount of \$5,344,016.20)

RESOLUTION NO. 07-587

1 **WHEREAS, the fiscal year 2007 will end at midnight, September 30, 2007 and all spending**
2 **authority granted under the 2007 budgets terminate at that time; and**

3 **WHEREAS, the Judicial Branch of the Nation has prepared and presented a budget to the**
4 **Legislative Council that reflects the needs of the Branch, a copy of the proposed said**
5 **budget is attached hereto and incorporated herein by reference; and**

6 **WHEREAS, the proposed FY 2008 Judiciary Budget includes employees salary in the amount of**
7 **\$3,559,913.99, other compensation at \$144,039.50, fringe benefits at 31% in the**
8 **amount of \$1,148,225.58, and operational cost in the amount of \$491,837.13, totaling**
9 **\$5,344,016.20 for FY 2008; and**

10 **WHEREAS, the Judiciary Committee and the Budget and Finance Committee of the Legislative**
11 **Council of the Tohono O'odham Nation have reviewed this budget and recommends**
12 **its approval and adoption.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council of the Tohono O'odham Nation**
14 **has reviewed and approved the Fiscal Year 2008 budget submitted by the Judicial**
15 **Branch.**

16 **BE IT FURTHER RESOLVED that funds in the amount of \$5,344,016.20 is appropriated and**
17 **authorized to be expended from the general fund approved by this Council for**
18 **support of the Fiscal Year 2008 budget of the Tohono O'odham Judicial Branch.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chief Judge and any designated official to expend and administer the budget as**
21 **attached, provided that any amendments affecting the funds or funding level shall**
22 **be submitted for further prior approval by the Tohono O'odham Legislative Council.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19TH Day**
24 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
25 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
26 **Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
27 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
28 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
29 **18, 1934 (48 Stat. 984).**
