

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2008 Legislative Branch Budget)**

**RESOLUTION NO. 07-589**

1 **WHEREAS, the Legislative Council is authorized "to manage any funds within the exclusive**  
2 **control of the Tohono O'odham Nation . . . and to appropriate these funds for the**  
3 **benefit of the nation and its members" provided that "[a]ll expenditures of these**  
4 **funds shall be pursuant to appropriations or budgets" authorization by resolution**  
5 **or ordinance (Constitution of the Tohono O'odham Nation, Article VI, Section 1(d)(2));**  
6 **and**

7 **WHEREAS, the Legislative Branch has prepared and submitted for review and approval of its FY**  
8 **2008 Legislative Branch Budget; and**

9 **WHEREAS, the Budget and Finance Committee and the Legislative Council have reviewed the FY**  
10 **2008 Legislative Branch Budget.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
12 **approves and authorizes expenditure of the FY 2008 Legislative Branch Budget in the**  
13 **amount of \$2,479,842.11, as per the attached budget, beginning October 1, 2007 and**  
14 **ending September 30, 2008.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 19<sup>th</sup>. Day**  
16 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,312.15 FOR; -0-**  
17 **AGAINST; 222.35 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
18 **Section 1(d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
21 **18, 1934 (48 Stat. 984).**
