11	in the amount of \$1,939.00 for review and approval.
12	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and
13	authorizes the expenditure of the FY2008 Food Distribution Nutrition Education
14	budget in the amount of \$1,939.00, in accordance with the attached budget.
15	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the
16	Chairman, Vice-Chairman and any designated official to expend and administer the
17	budget as attached, provided that any amendments affecting the funds or funding
18	level shall be submitted for further prior approval by the Tohono O'odham Legislative
