

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Department of Health and Human Services, Division of Family Assistance**  
**- FY08 Food Distribution Program Nutrition Education Funding Budget Account No. 11-1316)**

**RESOLUTION NO. 07-593**

1 **WHEREAS, the Department of Human Services is presently operating the Family Assistance**  
2 **Division, Food Distribution Program under an FY2007 grant with the United States**  
3 **Department of Agriculture (USDA); and**

4 **WHEREAS, the Food Distribution Program has been beneficial in providing food packages**  
5 **(commodity foods) and nutrition education to eligible households through tailgate**  
6 **runs throughout the Nation and nearby towns; and**

7 **WHEREAS, nutrition education funds have been made available to the Tohono O'odham Nation**  
8 **for FY2008 through the USDA in the amount of \$1,939.00; and**

9 **WHEREAS, the Tohono O'odham Department of Human Services, Family Assistance Division, Food**  
10 **Distribution Program has submitted the FY2008 Nutrition Education funding budget**  
11 **in the amount of \$1,939.00 for review and approval.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
13 **authorizes the expenditure of the FY2008 Food Distribution Nutrition Education**  
14 **budget in the amount of \$1,939.00, in accordance with the attached budget.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairman, Vice-Chairman and any designated official to expend and administer the**  
17 **budget as attached, provided that any amendments affecting the funds or funding**  
18 **level shall be submitted for further prior approval by the Tohono O'odham Legislative**  
19 **Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup> Day**  
21 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
24 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
25 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
26 **of June 18, 1934 (48 Stat. 984).**


