

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Department of Health and Human Services, Division of Family Assistance - FY08 Food Distribution Program Budget - Account No. 11-1315)**

**RESOLUTION NO. 07-594**

1 **WHEREAS, the Department of Human Services is presently operating the Family Assistance**  
2 **Division, Food Distribution Program under an FY2007 grant with the United States**  
3 **Department of Agriculture (USDA); and**

4 **WHEREAS, such tribal operations have been successful and beneficial to the Tohono O'odham**  
5 **Nation and the people; and**

6 **WHEREAS, it is in the best interest of the Tohono O'odham Nation to apply for FY2008 United**  
7 **States Department of Agriculture funds to assist eligible individuals and families with**  
8 **commodity foods; and**

9 **WHEREAS, the Tohono O'odham Department of Human Services, Family Assistance Division, Food**  
10 **Distribution Program has submitted for review and approval, the proposal and budget**  
11 **in the amount of \$181,138.00.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves and**  
13 **authorizes the FY08 Food Distribution Program budget in the amount of \$181,138.00,**  
14 **in accordance with the attached budget.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**  
16 **Chairperson and any designated official to expend and administer the budget as**  
17 **attached, provided that any amendments affecting the funds or funding level shall be**  
18 **submitted for further prior approval by the Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>. Day**  
20 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**  
21 **AGAINST; -0- NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**  
22 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**  
23 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
24 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
25 **of June 18, 1934 (48 Stat. 984).**
