

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Consolidated Healthy O'odham Promotion Program FY 2008 Budget
(October 1, 2007 - September 30, 2008))**

RESOLUTION NO. 07-595

1 **WHEREAS, the Tohono O'odham Nation receives a Special Diabetes Programs for Indians grant**
2 **through FY 2009 with a base budget of \$1,929,827.02; and**

3 **WHEREAS, by Resolution No. 99-149, the Tohono O'odham Legislative Council approved the**
4 **establishment of the Community Based Diabetes Prevention Program, funded by the**
5 **Special Diabetes Programs for Indians, authorized by the Balanced Budget Act of 1997;**
6 **and**

7 **WHEREAS, by Resolution No. 2000-182, the Tohono O'odham Legislative Council approved the**
8 **name change of the Community Based Diabetes Prevention Program to the Healthy**
9 **O'odham Promotion Program; and**

10 **WHEREAS, the Tohono O'odham Department of Health and Human Services is requesting the**
11 **Fiscal Year 2008 base budget of \$1,929,827.02.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 13 **1. Approves and authorizes expenditures for the Division of Health Promotion**
14 **Program Fiscal Year 2008 base budget of \$1,929,827.02.**
- 15 **2. Authorizes the Chairman, Vice-Chairman, and any designated official to expend**
16 **and administer the budget as attached, provided that any amendments affecting**
17 **the funds or funding level shall be submitted for further final approval by the**
18 **Tohono O'odham Legislative Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH. Day**
20 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
21 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
22 **Section 1(d)(2), (d)(3) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
23 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
24 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
25 **of June 18, 1934 (48 Stat. 984).**
