

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting and Approving the FY 08 Family Violence Prevention Services Grant)**

RESOLUTION NO. 07-597

- 1 **WHEREAS, prevention of injuries is a health priority for the Tohono O'odham Nation; and**
2 **WHEREAS, domestic violence is a source of injuries for the individuals and mainly members; and**
3 **WHEREAS, the Domestic Violence Program of the Health and Human Services – Community**
4 **Health Division and the Domestic Violence Coalition is working to raise awareness**
5 **of domestic violence and continue the development of services for domestic violence**
6 **victims and their families; and**
7 **WHEREAS, the Tohono O'odham Nation Department of Health and Human Services received a**
8 **Family Violence Prevention and Services Grant in FY-2006 for a total of \$139,866.62;**
9 **and**
10 **WHEREAS, the grant has expenditure period effective, October, 01, 2007 and ending September**
11 **30, 2008; and**
12 **WHEREAS, the Administration for Children and Families requests authorization to expend funds**
13 **from October 1, 2007 through September 30, 2008 of this grant in the amount of**
14 **\$139,866.62.**
15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby:**
16 **1. Accepts and approves the grant award G-06PCAZFVPS DHHS/ACF Family Violence**
17 **Prevention and Services Budget effective October 01, 2007 and ending September**
18 **30, 2008 and authorizes the expenditure of funds in the amount of \$139,866.62.**
19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairman, Vice-Chairman, and any designated official to expend and administer the**
21 **budget as attached, provided, that any amendments affecting the funds or funding**
22 **level of the grant shall be submitted for further prior approval by the Tohono**
23 **O'odham Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
25 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
28 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
30 **of June 18, 1934 (48 Stat. 984).**
