

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY2008 Tohono O'odham Department of Health and Human Services, Division of Behavioral Health, Recovery Community Services Program, Account No. 11-1484)

RESOLUTION NO. 07-601

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health**
2 **provides substance abuse, mental health, and prevention services; and**

3 **WHEREAS, the Division of Behavioral Health submitted an application to the U.S. Department**
4 **of Health and Human Services/Center for Substance Abuse Treatment for a Recovery**
5 **Community Services Program grant to provide peer-to-peer prevention programs to**
6 **support individuals in recovery and their families on March 31, 2006; and**

7 **WHEREAS, the Notice of Award was received for Fiscal Year 2007 on September 30, 2006 in the**
8 **amount of \$350,000 for the first year of a four-year grant; and**

9 **WHEREAS, the grant is scheduled to be awarded for the second year for FY 2008; and**

10 **WHEREAS, of the total grant amount of \$350,000 the budget proposed for Year Two reflects**
11 **19.35% in indirect costs; and**

12 **WHEREAS, the Recovery Community Services Program budget of \$350,000 for Year Two of the**
13 **grant is hereby submitted for review and approval by the Tohono O'odham Legislative**
14 **Council.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council:**

- 16 **1. Hereby approves and authorizes expenditures in accordance with the FY 2008**
17 **Recovery Community Services Program grant, and attached budget in the**
18 **amount of \$350,000 for the second year of a four year grant.**

19 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
20 **Chairman, Vice-Chairman, and any designated official to expend and administer the**
21 **budget, as attached, provided that any amendments affecting the funds or funding**
22 **level shall be submitted for further prior approval by the Tohono O'odham**
23 **Legislative Council.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH Day**
25 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
28 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
29 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
30 **of June 18, 1934 (48 Stat. 984).**
