

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2008 Phoenix Indian School Trust Fund Budget for Division of
Child Welfare Services Account #14-1321)

RESOLUTION NO. 07-605

1 **WHEREAS, the Tohono O'odham Nation was notified in November 1999 by the Inter-Tribal**
2 **Council of Arizona that the Nation is scheduled to receive its first distribution of the**
3 **Arizona Inter-Tribal Trust Fund in the amount of \$400,000.00 in December 1999**
4 **under Public Law 100-969, Arizona Inter-Tribal and Navajo Trust Fund; and**

5 **WHEREAS, the Tohono O'odham Nation was notified in November 2003 by the Inter-Tribal**
6 **Council of Arizona that the Nation is scheduled to receive its second distribution of**
7 **the Arizona Inter-Tribal Trust Fund in the amount of \$400,000.00 in December 2003;**
8 **and**

9 **WHEREAS, the Tohono O'odham Nation is scheduled to receive its third distribution of the**
10 **Arizona Inter-Tribal Trust Fund in the amount of \$400,000.00 in December 2007; and**

11 **WHEREAS, by Resolution Nos. 2000-253, 03-221, 04-642, 05-577, and 06-202, the Tohono O'odham**
12 **Legislative Council has approved allocations for all of the first and second**
13 **distributions of \$400,000.00 each of the Arizona Inter-Tribal Trust Fund to fund the**
14 **budgets of the Department of Health and Human Services, Division of Child Welfare**
15 **Services as required by Public Law 100-969 to use this trust income for child welfare**
16 **programs; and**

17 **WHEREAS, the Phoenix Indian School Trust Fund budgets continue to provide critical funding**
18 **necessary for the Division of Child Welfare Services to pursue its mission to serve and**
19 **protect the Nation's children; and**

20 **WHEREAS, by agreement with the Nation's Executive Office and the Department of Health and**
21 **Human Services, \$100,000.00 of the third distribution of the Arizona Inter-Tribal**
22 **Trust Fund will be committed to continue funding the FY 2008 Phoenix Indian School**
23 **Trust Fund Budget of the Department of Health and Human Services, Division of**
24 **Child Welfare Services, for the period of October 1, 2007 - September 30, 2008.**

25 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
26 **approve and authorize the Executive Branch to expend funds for the FY2008 Phoenix**
27 **Indian School Trust Fund Budget attached, effective October 1, 2007 through**
28 **September 30, 2008, inclusive of budget modifications throughout this period, in the**

1 amount of \$100,000.00 with no Indirect Costs, funded by the Arizona Inter-Tribal
2 Trust Fund.

3 BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice-
4 Chairman, and any designated official are hereby authorized to negotiate, execute
5 and expend the grant, provided however, that any budget amendments affecting the
6 funds or funding levels shall be submitted for further prior approval by the Tohono
7 O'odham Legislative Council.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20th Day
9 of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-
10 AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by
11 Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,
12 adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy
13 Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act
14 of June 18, 1934 (48 Stat. 984).


