

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2008 State IV-B Contract Budget for Division of Child Welfare Services**  
**and Approving the 10% Indirect Cost Rate for Title IV-B Budgets Account #12-1313**  
**(Amends Resolution No. 07-602))**

**RESOLUTION NO. 07-608**

1 **WHEREAS, the Tohono O'odham Nation, through the Division of Child Welfare Services, has**  
2 **historically operated a Family Preservation Program to promote safe and stable**  
3 **families; and**

4 **WHEREAS, the Tohono O'odham Nation has executed a State IV-B Contract, Intergovernmental**  
5 **Agreement between the Department of Economic Security and the Tohono O'odham**  
6 **Nation for the term of April 1, 2005 through September 30, 2008, as approved by**  
7 **Resolution No. 05-331; and**

8 **WHEREAS, the Tohono O'odham Nation with its Family Preservation Program, under this State**  
9 **IV-B Contract, invoices and receives additional funds from the State for services that**  
10 **the Family Preservation Program provides to Tohono O'odham families, thereby**  
11 **increasing funding which is critically needed for the provision of services, and the**  
12 **Nation wishes to increase this Program funding; and**

13 **WHEREAS, the Tohono O'odham Nation with its Family Preservation Program wishes to continue**  
14 **providing services, invoice for these services, and receive funds in FY 2008 from the**  
15 **State under the State IV-B Contract for services that the Program provides to Tohono**  
16 **O'odham families; and**

17 **WHEREAS, the Executive Branch developed and obtained Committee approval of the FY 2008 State**  
18 **IV-B Contract Budget in the amount of \$72,710.30, attached and incorporated by this**  
19 **reference, to be effective October 1, 2007 through September 30, 2008 and requests**  
20 **authorization to expend these funds in FY 2008; and**

21 **WHEREAS, the U.S. Department of Health and Human Services, Administration for Children and**  
22 **Families (ACF), has notified the Department that The Child and Family Services**  
23 **Improvement Act of 2006 (Public Law 109-288) restricts administrative costs to 10%**  
24 **starting October 1, 2007 for Title IV-B budgets, and the Department requests approval**  
25 **to submit this budgets with the following restricted 10% amount for indirect costs as:**  
26 **1. \$6,610.03 Indirect Costs for FY 2008 State Title IV-B Contract Budget, Acct. 12-1313.**

27 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
28 **approve and authorize the Executive Branch to expend funds for the FY2008 State IV-B**

1           **Contract Budget attached, effective October 1, 2006 through September 30, 2007, in the**  
2           **amount of \$72,710.30, funded by billing State IV-B funds under contracted**  
3           **Intergovernmental Agreement.**

4 **BE IT FURTHER RESOLVED that authorization is approved to restrict the Indirect Costs to 10% in**  
5           **Title IV-B budgets as required by The Child and Family Services Improvement Act of**  
6           **2006 (Public Law 109-288) in the following amount:**

7           **1. \$6,610.03 Indirect Costs for FY 2008 State Title IV-B Contract Budget, Acct. 12-1313.**

8 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairman, Vice-**  
9           **Chairman, and any designated official are hereby authorized to negotiate, execute and**  
10          **expend the grant, provided however, that any budget amendments affecting the funds**  
11          **or funding levels shall be submitted for further prior approval by the Tohono O'odham**  
12          **Legislative Council.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20<sup>TH</sup>. Day**  
14 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 1,963.4 FOR; 316.9**  
15 **AGAINST; 254.2 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
16 **Section 1(d)(2), (d)(3) and 1(f) Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
17 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
19 **18, 1934 (48 Stat. 984).**


