7		amount of \$152,768.22 is prepared to cover a six month period that will commence on
8		October 1, 2007 and end March 31, 2008; and
9	WHEREAS,	the six month (6) budget also includes the 2.5 percent employee salary adjustment that
10		is in accordance with the FY 2008 Budget Development Instructions; and
11	WHEREAS,	all Arizona Long Term Care Services (ALTCS) Program reimbursements obtained by
12		the Division of Senior Services including all savings from previous year budgets shall
13		be applied to the Arizona Long Term Care Services (ALTCS) base budget for current and
14		future program operations.
15	NOW, THE	REFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby
16		approves:
17		1. The Arizona Long Term Care Services (ALTCS) Program 6-month budget in the
18		amount of \$152,768.22 also includes the 2.5 percent salary adjustments.
19		2. All Arizona Long Term Care Services (ALTCS) Program client reimbursement funds
20		obtained by the Division of Senior Services shall be applied to the Arizona Long
21		Term Care Services (ALTCS) Program base budget for current and future program
22		operations.
23		3. All savings from previous year ALTCS budgets shall be applied to base budget for
24		current and future program operations.
25		4. The Tohono O'odham Nation's officials to wit: the Chairman, Vice-Chairman, and
26		any designated official are hereby authorized to negotiate and execute the grant,
27		provided however, that any amendment affecting the funding or funding levels of
28		this contract shall be submitted for further prior approval by this Council.
