

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Health and Human Services - Division
of Behavioral Health FY2008 Utilizing Revenue Budget-Account No. 18-1429)

RESOLUTION NO. 07-610

1 **WHEREAS, the Department of Health and Human Services, Division of Behavioral Health is**
2 **currently operating the Behavioral Health Division through an Indian Health Services**
3 **(I.H.S.) 638 Contract. The Seriously Mentally Ill (SMI) Program is a comprehensive Day**
4 **Treatment Program for Seriously Mentally Ill and Developmental Disabled Adults,**
5 **services which includes educational sessions on general mental health and substance**
6 **abuse, community activities, work projects, and case management. The original SMI**
7 **funds from the I.H.S. grant ended on August 31, 1990; and**

8 **WHEREAS, pursuant to Legislative Council Resolution No. 99-500, the Department of Health and**
9 **Human Services, Division of Behavioral Health, SMI Program has been collecting third**
10 **party reimbursement funds since September 1999 from the State of Arizona and has**
11 **since accumulated funds; and**

12 **WHEREAS, the Division of Behavioral Health, has accumulated funds to cover the Third Party**
13 **Revenue Budget Account No. 18-1429 in the amount of \$179,690.01 for FY08 personnel**
14 **and operational expenses (October, 01 2007 to September 30, 2008); and**

15 **WHEREAS, the Department of Health and Human Services, Behavioral Health Division request to**
16 **continue to cost share the Project Administrator position at 25% or \$13,532.14 from**
17 **October 1, 2007 to September 30, 2008 and fringe benefits to reflect the salary. Cost**
18 **share with MOH 50% and HOPP 25% to work and complete our SMI modular project**
19 **and future projects as needed for the development of services provided to the Nation;**
20 **and**

21 **WHEREAS, the Department of Health and Human Services, Behavioral Health Division request to**
22 **cost share the Business Manager position at 30% or \$17,583.66 from October 1, 2007**
23 **to September 30, 2008 and fringe benefits to reflect the salary. Cost share with MOH**
24 **10%, HTS 30% and HOPP 30% to provide economical development for the divisions**
25 **under the Department of Health and Human Services; and**

26 **WHEREAS, any future funds generated will be used for program personnel and staff support**
27 **expenses, i.e., insurance, utilities, communication expense, gas, oil and coolants,**
28 **supplies for office, program and kitchen, building materials, dues and subscriptions,**

1 **repair and maintenance for vehicles, equipment and building, professional services,**
2 **food, client support, special activities and special medical services; and**

3 **WHEREAS, a Third Party Revenue budget in the amount of \$179,690.01 for FY2008, has been**
4 **submitted for review and approval by the Department of Health and Human Services**
5 **for the Division of Behavioral Health.**

6 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 7 **1. The attached FY2008 Third Party Revenue Budget in the amount of \$179,690.01 to**
8 **supplement the FY2008 Department of Health and Human Services, Division of**
9 **Behavioral Health Budget is hereby approved to expend such funds in an amount**
10 **not to exceed \$179,690.01 to supplement the Division of Behavioral Health FY2008**
11 **budgets.**
- 12 **2. Approve to continue to cost share the Project Administrator position at 25% or**
13 **\$13,532.14 from October 1, 2007 to September 30, 2008 and fringe benefits to**
14 **reflect the salary. Cost share with MOH 50% and HOPP 25% to work and complete**
15 **our SMI modular project and future projects as needed for the development of**
16 **services provided to the Nation.**
- 17 **3. Approve to cost share the Business Manager position at 30% or \$17,583.66 from**
18 **October 1, 2007 to September 30, 2008 and fringe benefits to reflect the salary. Cost**
19 **share with MOH 10%, HTS 30% and HOPP 30% to provide economical development**
20 **for the divisions under the Department of Health and Human Services.**

21 **BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council hereby authorizes the**
22 **Chairman, Vice-Chairman, and any designated official to expend and administer the**
23 **budget as attached, provided that any amendments affecting the funds or funding**
24 **level shall be submitted for further prior approval by the Tohono O'odham Legislative**
25 **Council.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 20TH. Day**
27 **of SEPTEMBER, 2007 at a meeting at which a quorum was present with a vote of 2,534.5 FOR; -0-**
28 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**
29 **Section 1(d)(2), (d)(3) and 1(f) of Article VI of the Constitution of the Tohono O'Odham Nation,**
30 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**
31 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**
32 **of June 18, 1934 (48 Stat. 984).**
