

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY 2008 Department of Health & Human Services/Indian Health**  
**Service Budgets under the Nation's P.L. 93-638 Master Contract)**

RESOLUTION NO. 07-612

1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**  
 2 **Indian Health Service under Public Law 93-638; and**

3 **WHEREAS, the Executive Branch has approved and presented the budgets listed below for**  
 4 **programs funded by the Indian Health Service master contract effective October 1,**  
 5 **2007 through September 30, 2008, and requests approval of the budgets and**  
 6 **authorization to expend the funds; and**

7 **WHEREAS, the Nation has identified prior year savings associated with various programs funded**  
 8 **from the Indian Health Service master contract and has developed budgets proposing**  
 9 **to carry forward these savings in FY 08, as listed below.**

10 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
 11 **the budgets presented below, and authorizes the Executive Branch to expend funds**  
 12 **for the programs listed herein in the amounts indicated effective October 1, 2007**  
 13 **through September 30, 2008;**
